UBC Digital Payment Program (DPP) provides participating UBC departments with secure, real-time authorization and processing of online payments through credit card rails (including credit, prepaid credit and signature debit). As with other credit card payment processes on campus, DPP is subject to UBC Payment Card Industry Data Security Standard (PCI DSS) compliance, with which stores must be compliant at all times.

UBC Entities Only:

DPP supports digital payment processing behalf of UBC entities only. We do not support payment processing on behalf of a subsidiaries or related entities.

Credit Card Security:

1. DPP merchants are not permitted to obtain, collect or store sensitive credit card information.
2. DPP merchants are not permitted to process payments on the behalf of their customer or the cardholder.
